## Terms and conditions

In keeping with the finest traditions of luxury service and safety I/We understand and agree to the following rules of conduct while using the service of Roman Limousine Service:

- <u>All deposits are non-refundable</u>. A reservation is not guaranteed without a deposit. Checks will only be accepted up until 7 days prior to any scheduled event. Cash or credit card are the only two forms of payment accepted at the time of pick-up. Charges begin when the vehicle arrive at the pickup location.
